Dear Prospective Student,

The Bucks County Community College is accredited by the [National Board on Fire Service Professional Qualifications](#) (ProBoard) and the [International Fire Service Accreditation Congress](#) (IFSAC). This means that the levels of accredited professional certification offered by the Bucks County Community College meet or exceed [Occupational Safety and Health Administration \(OSHA\)](#) and [National Fire Protection Association \(NFPA\)](#) Standards, along with all requirements set forth by ProBoard and IFSAC. The process to become accredited is voluntary and only the most capable agencies apply for consideration. When an emergency services training agency applies for the accreditation their policies are studied, procedures and processes are tested to ensure their certification testing process is evaluated and held to the standards of the accrediting body and compliance with the current NFPA standards. The Bucks County Community College is also an accredited through the [Middle States Commission on Higher Education](#), which brings additional value knowing your training and certification needs are coming from an accredited higher educational institution.

The Bucks County Community College (formally the County of Bucks) has been ProBoard and IFSAC accredited for approximately 15, starting back in 1994 when the dual accreditation was sought and successfully obtained. Over the years, Bucks County Community College has continued to add additional professional certification levels and the courses to obtain those levels.

The Bucks County Community College is pleased to announce our revised Fall 2009 Daytime Resident Certification schedule. The Doylestown Training Facility is located at 1760 South Easton Road, Doylestown, PA 18901, just minutes from NAS/JRB Willow Grove. The facility is within ninety minutes of the Philadelphia (PHL) and Lehigh Valley (ABE) International Airports. [Directions and local lodging](#) facilities can be found on our website.
